No exemptions will be allowed for submission of EMD. Online Tenders of the bidder, which are received without Earnest Money Deposit, will be summarily rejected.


3. Tenders will be received online from 26/10/2019 to 16/11/2019 up to 10.00 AM and will be opened on **18/11/2019 @ 10.00 AM.** If the date of opening of the tender happens to be holiday or if any, the tenders will be opened on the next working day.
4. The limited tender will be opened at the prescribed time and date in the presence of the bidders who are present at that time.
5. The time allowed for carrying out the work execution is **60 (Sixty) days** from the date of issue of written orders to effect the commencing the work.
6. Bidder should quote his/her rate both in words and in figures per unit. Any corrections in the rate should be attested by the dated signature of the bidder. Otherwise such limited tender is liable for rejection. The amount for each item should be worked out and the requisite total to be mentioned.
7. Since, it is part of the conservation work to the centrally protected ancient monuments and not modern works like CPWD, it is understood that the bidder has inspected the site and accessed before bidding. No claim whatsoever will be entertained at any stage, in this regard.
8. The execution of work should be completed in all respects to the entire satisfaction of the Superintending Archaeologist, Archaeological survey of India, Thrissur circle, Thrissur, or any officer authorized by him / her within the stipulated time and no extension of time will be normally allowed.
9. The contract is subject to availability of funds, if funds are exhausted, the tender can be terminated at any time after serving notice.
10. The EMD of the successful contractor who fails to execute the work within the dates specified in the work order is liable for forfeiture to government.
11.
